### Candidates!

The upcoming March 23-24 NJLP Convention will be an exciting event because Lou Jasikoff's "Operation Full-Slate 2007" is bearing fruit. Lou has found candidates from all over the state and encouraged them to run as NJLP candidates for state office (State Senate and Assembly) this year. Some have never run for political office before, but all are highly motivated to stand up and battle for liberty. This issue of the *New Jersey Libertarian* will highlight some of the enthusiastic and energetic freedom fighters Lou has recruited.

### Sean Christopher Colón – Assembly, 22<sup>nd</sup> District

I am 23 years old and am of Puerto Rican and Irish descent. I was born in Paterson, NJ and raised in West Orange until I went to college at the age of 18. I have a BA in International Relations from Tufts University and graduated from US Army Airborne School. After college I moved back to West Orange and I now reside in Scotch Plains. I am Director of Business Development at Allied Old English Inc., a food manufacturing and brand management company in Port Reading, NJ.



I am running for Assembly as a Libertarian for many reasons: 1) I am tired of the two party political system that has been maintained and promoted by gerrymandering and the "good ole boys" environment in Trenton and Capitol Hill. 2) I am socially liberal in the sense that I believe people should be free to do whatever they wish as long as they are not infringing on the rights of others. 3) I am fiscally conservative, because I believe that all nonessential government programs should be cut to allow for a much smaller budget and much lower taxes. 4) My personal and political beliefs are most closely aligned with those of the Libertarian Party and I am tired of having to choose between the Democratic Party and the Republican Party, whichever candidate being the lesser of two evils.

### Derek DeMarco – Assembly, 40<sup>th</sup> District

I am twenty seven years old, born and raised in Wayne, where I currently reside. I am a Pennsylvania State University graduate with a Bachelor of Science degree in Business with a concentration in Entrepreneurship.

I am running as a Libertarian for the office of Assemblyman because I believe in the principles of small government and change will not come from the Democrats or Republicans. The ten day State shutdown in July 2006 shows the spending problem within the State budget and highlighted the importance of a strong Constitution to protect the people from an out of control government. I was happy to see that the State acknowledged the Constitution then and followed what was written, because the State has disregarded so many other Constitutional aspects. Unfortunately, the "resolution" of the shutdown was a billion dollar tax hike!

The issue of property is at a crossroad in New Jersey. Property taxes are the highest in the nation. Eminent domain abuse seems relevant with the Highlands Act, because the state does not have the budget to purchase the land, so they seize it. The smoking ban now extended to the casinos and race tracks also violates a property right. If you own a business you should be free to choose smoking in your establishment. These are just a few of the issues that have convinced me to run for State Assembly in New Jersey's 40th district.

## Alex Kachmar – Assembly, 34<sup>th</sup> District

Alex is a 25 year old Senior Analyst with a Master of Science in Management from NJIT and a Bachelor of Science in International Business from Boston University. Why is he running as a Libertarian? Here is what Alex says: "I have a strong economic libertarian viewpoint and believe in free markets with limited to no governmental regulations. I think income taxes and capital gains/dividend taxes should be abolished both at the state and federal levels, and I am against legislation that dictates how business owners run their businesses, e.g., I strongly oppose the recent legislation that mandates that NJ bars/restaurants must be smoke-free. In terms of social issues, I agree with the Libertarian Party on ending drug prohibition, plus it wastes taxpayer dollars, which no real conservative should tolerate."

Alex had been active with Massachusetts LP and their income tax repeal initiative, and he looks forward to NJLP activism. He currently resides in Montclair.

## Ken Chazotte, Senate, 12<sup>th</sup> District

Retiring NJLP State Chair Ken Chazotte has accepted Lou Jasikoff's charge to lead the 12th District (Monmouth County) NJLP challenge. Ken will run for State Senate and he is recruiting two more Libertarians to fill the ticket.

## Emerson Ellett and John Taylor, 11<sup>th</sup> District

Dr. John Taylor an **elected** member of the Highlands School Board and Emerson Ellett, the 1980 NJLP candidate for U.S. Senate, both volunteered to run for state legislature in the 11th District.



Emerson says, "I'm running because the people of NJ are being taxed out of their homes. They're being bankrupt by runaway spending, in particular on the *de facto* monopoly school system. The state constitution calls for 'thorough and efficient' education. Some school districts allegedly are graduating functional illiterates, which is not 'thorough,' at an exorbitant cost, which is not 'efficient.' In any event school spending is out of control. Clearly we need an alternative to the current system, which I believe can only be provided by competition. That will be my message to voters."

## Jeff Hetrick – Assembly, 21<sup>st</sup> District

When asked why he was running, Jeff replied:



"A quick look at what is happening in New Jersey, and nearly anyone can see the rampant expansion of government, waste, corruption and ever more increasing infringement onto people's personal choices. My goal in running for NJ Legislature as a Libertarian is intended at a minimum to increase people's awareness to these and other dilemmas, and to show that there are options for reducing government spending, lowering

taxes and giving people back the choices that the government has already made for them."

## Darren Young – Senate, 21<sup>st</sup> District

Darren Young is 46 years old and has been a member of the LP since 1995. He ran for Congress in four elections and debated Bob Franks in 1998 and Mike Ferguson on live TV in both 2002 & 2006 plus had appearances on Comcast Newsmakers. He has a math degree from Rutgers College and has been a software developer for 24 years working for FMI in Carteret. He lives in Summit with his wife Jane, and they have two children.



## Dolores Makrogiannis – Assembly, 21<sup>st</sup> District

Dolores has a BA in humanities from Thomas Edison College and works as a Documentation/Administrative Specialist for Kytogenics Pharmaceuticals in Chatham

She's been an LP member since 1997 when she helped with the Murray Sabrin for Governor campaign. She lives in Scotch Plains.

## 40<sup>th</sup> District – Full Slate!

## Paff in Edgewater and Kenilworth

### Paff stops Edgewater censorship

Edgewater's Borough Council seats have typically been populated by staunch members of the Democratic Party. A few years ago, however, a slate of self-described "watchdog" candidates ran and some of them were elected. The "watchdog" website is at: <http://www.edgewaterunited.com/bio.html> .

The presence of dissenting voices was displeasing to the Democratic majority of the council. So on February 20, 2007, the Council planned to formally introduce an ordinance to amend the council's bylaws and rules of procedure to include "measures that would reduce disruptive behavior ... and to promote the orderly conduct of business." The "watchdogs," however, saw it very differently. On councilwoman posted the following colorful comment "tell this totalitarian, un-democratic, decidedly un-American group of imposters what you really think ... My attorney looked at the [ordinance] and remarked, 'Who runs your town, the Taliban?'"

John Paff entered the fray by posting this critique:

I am not a resident of Edgewater, but serve as the "Open Government Advocate" of the New Jersey Libertarian Party. I am troubled by changes that Ord. 1360-2007 seeks to make to Borough Council's bylaws. ...

Roberts Rules of Order is a time-tested system that carefully balances the majority's desire to expeditiously advance its agenda against the minority's right to dissent and to have their voices meaningfully heard. The proposed amendments, however, disrupt this delicate balance.

According to the proposal, for example, no member of the council is allowed to interrupt another member while speaking, under threat of being "called to order" by the mayor and possibly being removed by the sergeant at arms. But Roberts Rules of Order expressly authorizes certain instances when a speaker may be interrupted, such as calling for the orders of the day, raising a point of order or objecting to the consideration of a question.

Since the council bylaws supersede Roberts, these bylaws, in effect, prohibit these motions being used in a manner that Roberts finds appropriate. Since raising a point of order or calling for the orders of the day are motions typically employed by members of the minority, limiting the use of these motions will trample on the minority's rights most heavily.

So what happened? On Tuesday, February 20 the Council "tabled" its proposed ordinance 6 to 0. So, the "watchdogs" won, at least temporarily. John and open government are on top in Edgewater!

### Secret police settlement uncovered in Kenilworth

John wins a big disclosure by his efforts in Kenilworth. Here is how writers from the *Star-Ledger* on February 11 and the *Union Leader* on Feb 6, 2007 described John's triumph.

A lawsuit brought against the Kenilworth chief of police and borough council by a police sergeant, who alleged discrimination because he is Italian-American, was settled out of court in an agreement that includes \$70,000 and lifetime family medical coverage. This agreement, which was intended to be kept from public view, was discovered by chance through the efforts of John Paff of the Libertarian Party.

Paff has run a dogged campaign to expose violations of the Open Public Records Act by public officials in New Jersey. On July 19, 2006 he made a request to the borough for records of public meetings, including minutes of a work session, resolutions by the Borough Council to go into closed sessions and minutes from some of the closed sessions. In response, the borough provided information that, according to Paff, largely failed to meet his request. The only information that met his request included minutes from one closed session, with some parts redacted.

Paff considered that a denial of his request and filed a complaint on Aug. 11, 2006 with the New Jersey Government Records Council demanding that the borough be declared in violation of OPRA laws, and be asked to grant him access to the requested records and a disclosure of the unredacted minutes of the meeting. The parties subsequently signed a mediation settlement agreement in September in which the borough was required to provide the requested information.

Thereafter, the borough wrote to Paff stating that the requested resolutions were not available because only a voice motion was required to go into closed sessions. The borough also explained that redactions were made in the minutes of one of the closed sessions to avoid violation of a confidential provision in a settlement agreement that arose from a litigation.

Paff then asked for the settlement agreement, which, after some back-and-forth arguing, was released to Paff on Jan. 19. "It was a battle for six months to get it," said Paff. "There are several layers of secrecy here."

Paff's initial intention in requesting the information was to see whether the Borough Council complied with OPRA requirements with regard to closed sessions. After seeing the redaction, Paff requested an explanation, which ultimately revealed to him the nature of what was involved. "This can be an abuse of executive sessions, keeping the public completely in the dark," he said. "To me, it's not about this case but about people knowing what their officials are doing."

## Clifton Next for Paff?

In Clifton John wrote to Clifton Mayor James Anzaldi complaining that City Council's closed session minutes are so lacking as to violate the law. John says, "I'm trying to open this city up, little by little. In August, I succeeded in getting them to agree to provide more information in their executive session resolutions." Passed unanimously.

## Employee Free Choice Act

The Employee Free Choice Act is all about empowering unions at the expense of worker choice. The bill will enable unions to assert enormous power that without this proposed legislation they otherwise would be unable to achieve. The card-check system is a powerful tool in the hands of a union seeking to gain company representation. It opens the door to worker intimidation by allowing union representatives to twist the arms of those who did not sign the card. What's worse is that the card-check system will make decertification of the union all but impossible. And, of course, the present secret ballot election allowing anonymous choice by workers will be terminated.

Union representation has been declining for 50 years because workers have rejected the heavy hand of unionism, and also because improved worker skills and technology have made union benefits a backward-looking approach to job satisfaction, higher wages and upward mobility. In addition, workers have no voice in union dues spent for political purposes. This is the equivalent of taxation without representation, which effectively characterizes unions as authoritarian organizations.

Big Labor is in a box today, and their leaders know it. Only through the misnamed Employee Free Choice Act can they expect to regain share in the 140 million work force market. Consistent with liberal orthodoxy, this requires the use of force rather than choice in order to meet their objectives and which in turn will serve to create further distortions in our economy.

## From the First Issue

Volume I number 1 of the NJLP's monthly newsletter *Premise* was dated November 1972 and it announced the formation of the NJLP on October 6, 1972. The new party's first action was to endorse the national LP ticket of John Hospers for President and Toni Nathan for Vice President. Yearly membership dues were set at \$7.50.

The first article read "Freedom Revived in N.J." with the founding of the party. In addition to the Hospers/Nathan endorsement, *Premise* contained an article condemning a \$659 million transportation bond issue and urging "Vote an emphatic, indignant NO on the transportation bond issue." Finally, NJLP Chairperson Robert Steiner extended "an invitation to join us." His invitation concluded: "Hop aboard the only freedom train which is still running in the United States—the Libertarian Party."

It's been 35 years and the freedom train is still running!

## Reaching Out for Liberty

Outreach is the most rewarding activity for libertarians. It's not just because of the new people who become attracted to us, but also because of the interesting people that you meet and what you can learn from them.

Running for office or collecting signatures to place issues and candidates on the ballot are also important. But sitting at a booth is easier and more convivial than soliciting signatures and votes. Some singles have told me that staffing a booth is a great way to approach interesting people. It's also a way of collecting feedback about our wonderful cause and of correcting false information about libertarians. You can also find out how others are advancing or not advancing this cause, even if they do not call themselves libertarians.

The best places to set up tables are at rallies and conferences, both indoor and outdoor. These are places where concerned people meet to network as well as vent their grievances. Covering such events for an article in a zine or blog is a good way to get recognized for speaking engagements and future paid gigs in the movement.

Work with other libertarian activists so that you can take a break at your table. It's more fun, plus you can compare notes afterward. Post future events and their libertarian potential on local lists and ask for other volunteers.
