THE SWEET SMELL OF SUCCESS

Dick Siano, Chairman of the Hunterdon County Libertarian Committee, outpolled his Democratic opponent 383 to 208 (24 write-ins for the Republican who lost in November) in a runoff election for Kingwood Township Committee. He becomes the first Libertarian Party candidate to win a partisan election outside of Fairbanks, Alaska and joins Alaskans Dick Randolph and Ken Fanning as the only elected Libertarian Party officeholders who have defeated Republicans and Democrats in head-to-head electoral contests.

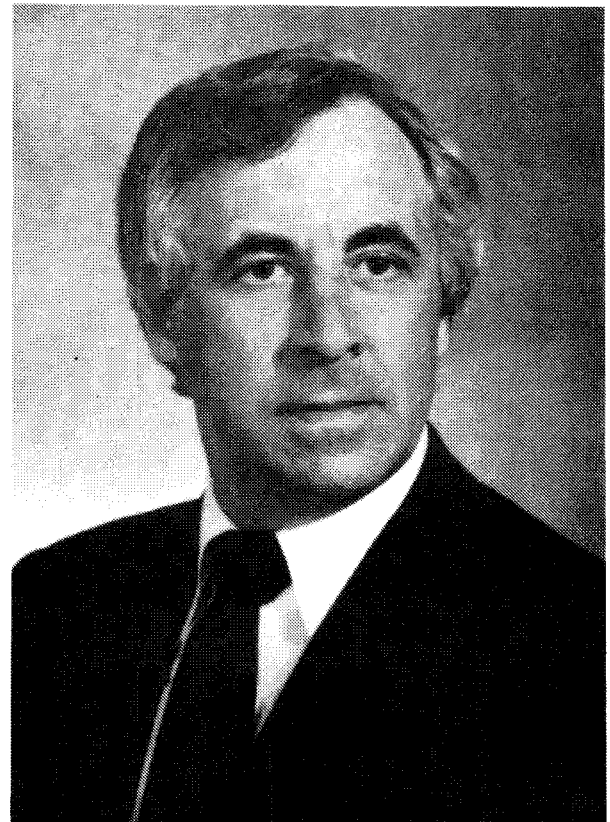
According to his wife Sandy, Dick won the campaign because he "worked ten times as hard as the other candidates."

Siano centered his campaign around three basic issues. The first was deregulation--he opposed restrictive building, fire, and zoning ordinances. Second, he came out against the property revaluation now being prepared for in his town. Third, he opposed the \$400,000 budget the town committee has prepared for land and construction of a new municipal building.

Siano and fellow local libertarians worked hard on his campaign and are to be congratulated for their success. Will YOU be the next NJLP winner? (See the article by Jonathan Steele.)

In a two-hundred-year-old farmhouse high above the Delaware, near where Washington crossed to turn the tide of war, a small band of latter-day patriots and their friends gathered in celebration of a hard-won battle--the outcome of which had been in doubt until the last vote was counted. lution were toasting the election of Richard Siano, Libertarian, to Township Committee of Kingwood Township, Hunterdon County. At 8:00 PM December 29, 1981, the Libertarian Party won its first contested partisan election in the Lower Forty-nine.

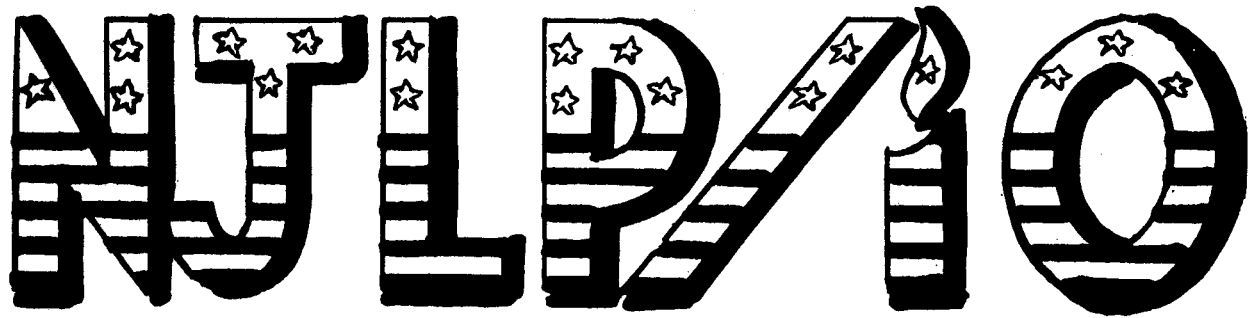
Siano had defeated the Republican incumbent and tied with a Democrat in the November election. Neither called for a recount, and the tie had to be broken by a Special Election. Already well-known in the community from serving on the Board of Health, fund-raising for service organizations and a door-to-door campaign in which he made clear that if elected he would oppose revaluation, fight to limit municipal spending, and work to repeal restrictive local ordinances, Siano redoubled his efforts to win. On the eve of the Special Election an intensive telethon was directed at the candidate-less Republicans and Independents where Dick felt he had considerable support. On Election Day poll watchers reported who had voted. Late in the day registration lists were scanned for likely supporters who had not yet voted. These were called again and asked to vote, and the telephones did not rest until less than an hour before poll closing.

The vote was Siano 383, Democrat 208, Republican write-in 24. The Libertarian had won with 63% of the vote--almost a 2-to-1 majority. As John Schafer, erstwhile Libertarian candidate for Congress and valuable aide to Ed Clark and Siano, exclaimed with intense satisfaction, "How sweet it is!"

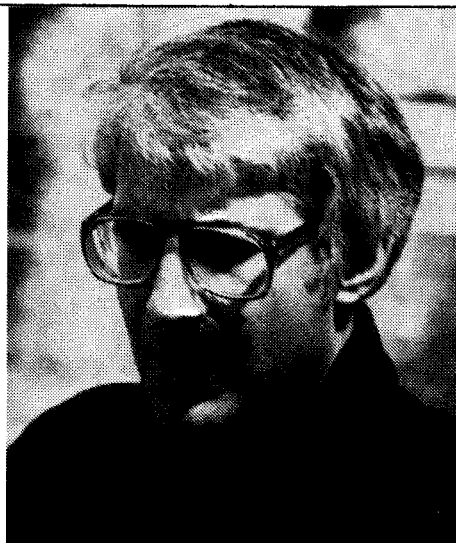

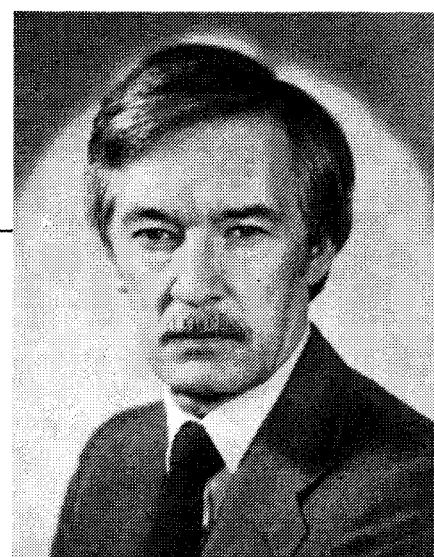

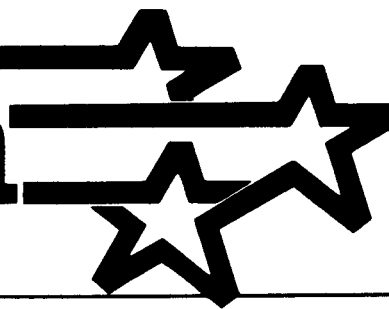

Who He Is — Why He Can Win

BIOGRAPHICAL SUMMARY

Richard L. (Dick) Randolph was born in Salmon, Idaho in 1936 and moved to Alaska in 1960. A former schoolteacher, he established his own successful insurance business in Fairbanks in 1964, which he still operates. He is a past state officer of the Junior Chamber of Commerce, a licensed pilot, and an active sportsman. Dick and his wife Lydia have five children, ranging in age from 13 to 23.

POLITICAL BACKGROUND

Dick first became involved in politics as a volunteer for the Republican Party in 1964. In 1970, he was elected to the state House of Representatives from Fairbanks and was re-elected in 1972, but he resigned from the legislature and left the Republican Party in 1974 in protest of policies with which he could not in good conscience agree.

In 1976, Dick became acquainted with the Libertarian Party, then a very small organization in Alaska, and volunteered to be State Chairman of Libertarian presidential candidate Roger MacBride's campaign. Dick's enthusiastic promotion and recruitment produced six per cent of the vote for MacBride in Alaska (ten per cent in Fairbanks)—a record-breaking showing for a new, small party.

In 1977, Dick was elected to the Libertarian National Committee, a post to which he has been re-elected twice. His political activities during this year focused primarily on building the size, strength, and influence of the Libertarian organization.

In 1978, Dick ran for and was elected to the Alaska House of Representatives, becoming the first elected Libertarian office holder. In 1980 he was re-elected—finishing first in a field of 18 candidates and nearly doubling his 1978 vote total—and was joined in the legislature by Fairbanks Libertarian Ken Fanning.

POLITICAL ACCOMPLISHMENTS

During his first Libertarian term, Dick built statewide recognition of and respect for the Libertarian Party and himself through his principled positions on state issues, positions which combined responsible criticism with creative new solutions. With the addition of a second Libertarian legislator in 1980, Libertarians became a true alternative political force in the state, effectively holding a "balance of power" in state politics and spearheading successful and well-publicized moves to reduce the role of government in the lives of Alaskans.

Dick played the leading role in repealing the state income tax, first by sponsoring a statewide initiative petition calling for this move, then by leading the legislative fight to make the repeal a reality. He has also played a key role in efforts to privatize land ownership.

CAN DICK WIN?

Dick Randolph has been a winner all his life—a man who has succeeded by combining deep, principled convictions with sound, realistic judgment. His personal electoral victories thus far have reflected years of hard work in building an effective statewide grassroots organization of Libertarians and many others who share his views and respect his courage.

Libertarians are the third major political party in Alaska, and they come closer to Alaskan values on such issues as taxation, land use, and individual rights than do the other two parties. The present governor was elected with only 39 per cent of the vote in a four-way race; Alaskans are used to thinking and voting independently, and care less about party labels than about principles, issues, and the character of the candidates.

Dick Randolph has the recognition, the talent, the organization, and the statewide respect to be the next governor of Alaska. He needs and deserves maximum support in his pathbreaking effort.

Old Tappan

Old Tappan voters yesterday returned the two Republican incumbents to the borough council, as Libertarian Party candidate Henry Koch went down to a sound defeat.

Councilman Joseph Salazar, who was seeking his second three-year term, led with 1,001 votes. Nicholas Falbo, who has served two years on the council, was elected to his first three-year term with 883. Koch received 410 votes. The council will remain all-Republican.

Of the borough's 2,443 registered voters, 1,500, or 61 percent, turned out at the polls.

In his race for borough council in Old Tappan Henry Koch received 198 votes out of 533 in his own district for 37%, and a very respectable 27% overall. Keep up the good work, Henry!

Libertarian wins seat in township

KINGWOOD TOWNSHIP (AP) — Airline pilot Richard Siano, who bucked the local government to gain approval for a private landing strip, is the first Libertarian candidate to win a partisan election outside Alaska, according to party officials.

Siano, a 43-year-old TWA captain, scored a 383-208 victory over Democrat Andrew Madaychik in a special election last Tuesday that was prompted by a 308-308 tie between the two in November balloting for the three-member township committee.

Results of the special election in the Hunterdon County township were filed yesterday.

William George, state Libertarian Party chairman, said in Westfield that Siano was the first party candidate elected to a partisan office outside Alaska.

He said a Libertarian, whose political philosophy calls for less government interference with individual rights, was elected to the Rahway school board in the mid '70s.

Sample Ballot Out In Kingwood Vote

Sample ballots are out for a special election Dec. 29 to break a tie for township committee in Kingwood.

It is the first such election in modern Hunterdon history. And it is the first ever in the state, possibly in the nation, involving a Libertarian Party candidate.

Libertarian Richard Siano and Democrat Andrew Madaychik tied in a three-way election Nov. 3, defeating Republican incumbent Samuel Leon.

Gaetano DeSapio, township attorney, said the only way to resolve the dilemma was by a new election, not by appointment.

Neither Siano nor Madaychik sought a recount.

The Republican slot on the ballot is blank. Leon declined to run again, and his party did not put up a candidate. Voters can write in a name if they choose.

Siano is an airline pilot. Madaychik is a former committeeman.

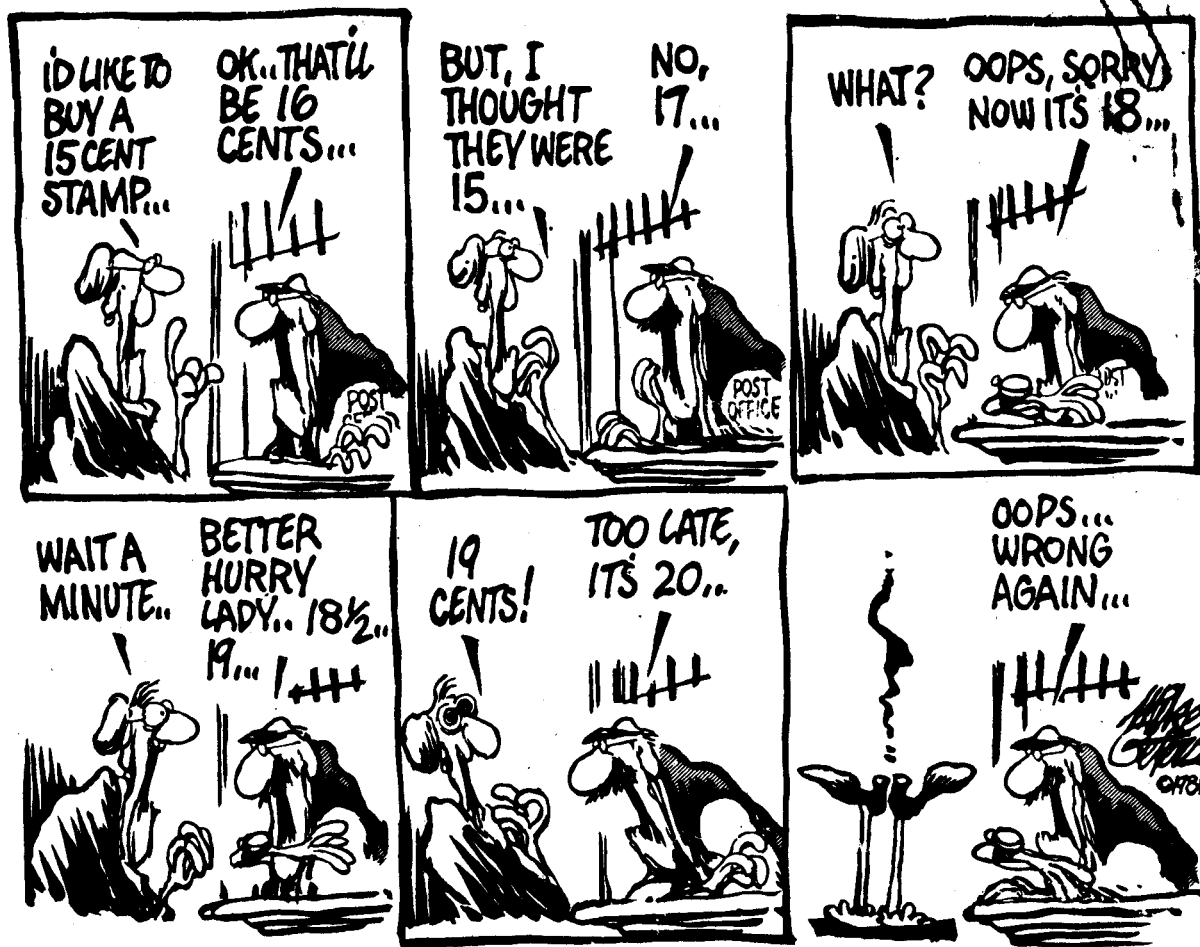
