NJLP Convention '79

As all who attended could see, the 1979 NJLP Convention was a resounding success. Thanks to the considerable efforts of BillGeorge, the entire program was well attended, surpassing earlier projections, and the NJLP managed to turn a welcome profit.

Ron Wishart's key note speech (and some good coffee) got the ball rolling with some encouraging remarks, describing the NJLP's past accomplishments, and future possibilities.

The late morning and early afternoon agenda consisted of lunch and the
interesting and imformative workshops
of educator John Holt, tax rebel Irwin
Schiff, and lawyer Gary Greenberg.
These drew substantial numbers of nonLibertarians, thereby providing excellent exposure for the Party and contributing to the financial success of
the convention. I feel that these
'outsiders' went home quite impressed.

Later in the afternoon, before dinner, the program concluded with a panel debate on the legalization of abortion. Like so many of these debates, the two sides of our panel could find little opportunity for agreement. The two sides repeatedly drew diametrically opposed conclusions from each set of facts. One thing is certain, however. The intensity of conviction exhibited by all the panelists indicates that this is indeed an important issue, warranting extremely thorough examination, discussion and thought before the LP takes any cut and dried stand.

I think that the financial success of this convention suggests the desireability of similar fund raising affairs wherein the Party can gain exposure, have a good time and raise cash simultaneously.

After the NJLP's highly successful annual convention what will the party do next? Well, petitioning for the N.J. Assembly races this fall must begin immediately. Unlike the chaotic scramble last year, the NJLP's petition coordinator Chris White should have ample signatures to file well in advance of the April 26, 1979 deadline. Anyone who can help collect signatures for candidate petitions should contact Chris at 201/842-3604.

The 1980 LP presidential candidate race is underway with Bill Hunscher, Chairman of the New Hampshire LP, and Ed Clark, '78 California LP candidate for Governor (375,000 votes), as announced contenders for the nomination. We hope to schedule dinners for both candidates so NJLP members can meet and hear them. Watch future issues of the N.J. Libertarian for more information.

Several state issues bear watching. Our legislature is considering an election law "reform" (Assembly Bill 744) which would greatly increase the petition requirements for candidates to get on the N.J. Ballot. For more info. call Chris white. In addition our paternalistic representatives are considering raising the N.J. drinking age to 19--or 21. If anyone is interested in challenging this action, please call me at 201/928-0758 to volunteer to be NJLP coordinator on this issue.

Barry Siegel (201/743-8686) and Ken Kaplan (201/672-6692) have prepared a draft NJLP proposal for Initiative and Referendum as an alternative to the half-hearted bills in the N.J. legislature. Finally, NJLP Vice Chairman Lee Schubert is scrutinizing the latest IRS proposal on private tax-exempt schools. It's better than before, but still deficient, so the NJLP will again submit comments in opposition. Call Lee at 201/540-8318 for more information.

All in all there is plenty for NJLP members to do this year. Our successful convention is an excellent start, so let's keep going strong.

LIBERTARIANISM vs. ANARCHY

When Libertarians are asked to name the proper (Libertarian) functions of government, their answers range from "It has none." (Anarchy), to "It has very few." (perhaps to enforce the laws and provide natioal defense).

Some have even proposed a third answer: "Who cares?". Proponents of this argument claim that, so long as the current trend is towards bigger government, our primary concern need only be to reverse that trend. Someday the question of 'How small' will become relevant, but for now, it is academic.

I believe there are serious flaws in this argument.

To start, such a nebulous, indecisive, non-position can only injure the credibility of the Party. By offering our candidates as alternatives to Tweedledee and Tweedledum, we are distinguishing ourselves from the ACLU, the National Taxpayers Union, and other single-issue organizations. We are a political party (i.e., we run candidates for political office) and as such, require a comprehensive, coherent stand on issues of importance. Any indecisiveness on an issue so fundamental to our entire platform will detract from the voters' perception of our candidates.

Secondly, as Ayn Rand has recently pointed out, we must distinguish ourselves from Anarchists - in our own minds and the minds of the voters. We are not Anarchists (hence our unique name). In fact, Libertarians widely regard Thomas Jefferson as one of the first Libertarians and, while he never underestimated the danger of powerful government, Jefferson clearly saw the need for some form of constitutional government.

In response to your January, 1979 NJ Libertarian article: the right of a woman to choose an abortion is certainly in keeping with the libertarian philosophy and belongs in the LP platform. I have a right to terminate my pregnancy, whatever the reason-failure of contraception, fetal deformity, financial hardship, rape, juvenile or middle-aged pregnancy, or even "inconvenience."

In regard to the rights of the fetus, I don't believe any such rights exist. As I see it, the fetus is not a person entitled to

protection of the law.

But suppose some fetal rights do exist -- just what are they and, more importantly, who will decide what they are? As an expectant mother will I be violating the fetus' rights by smoking, drinking, taking aspirin or tranquilizers, or using an anesthetic during delivery? Would I be tried for murder if I took a drug to induce abortion? If I fell during volleyball, thereby inducing premature birth, would I be guilty of assault? In short, if the fetus has the rights of a child, then logically the law must dictate lifestyle to protect the "unborn citizen."

Certainly, the issue is a difficult one-but it is and must be decided by the individual and not dictated by the law. Wrestling with the morality of abortion is the sole responsibility of the pregnant woman. Keep the law and

the state out of it!

Editor, the N.J. Libertarian:

The panel on abortions at our state convention session would have been more effective if a clear statement of the rules of procedure had been provided. At the dinner which followed, some of us concluded that such a statement should be prepared, both to facilitate in retrospect understanding of the panel discussion and as a guide in preparing any future panels. We therefore constituted ourselves as a Volunteer Committee and prepared the following list of regulations.

ABORTION PANEL RULES OF PROCEDURE

- 1. Four members of the panel will be called "Panelists", two being chosen to present each side of the question. Each will be given in turn 15 minutes to state his/her position, and then each will have 5 minutes for rebuttal. Following this, each will be given the opportunity to respond to questions from the floor.
- 2. An additional member will be called the "Moderator", and will serve as neutral chairman, maintaining order throughout the discussion and question periods.
- 3. A sixth member of the panel will be called the "Panelist of Supreme Authority". He will be selected from among the Party leaders and/or candidates for high office, and will preferably be a practicing gynecologist. He will have the following responsibilities:
 - 3a. He will identify the panelists whose position is WRONG, and point out the flaws in their arguments.
 - 3b. Lest his position appear to be biased, he will point out some flaw in presentation made by each panelist whose position is RIGHT.
 - 3c. Lest the identification of flaws required in item 3b. mislead anyone as to his own position, he may announce that he is looking for something to criticize in the RIGHT panelists in order to avoid accusations of bias.

- 3d. The Panelist of Supreme Authority will close the discussion with a statement of the CORRECT basis for decision on the question. He may, for example, point out the irrelevance of arguments by both sides as to rights of mothers, fathers, the fetus, etc., directing all Libertarians to base their judgments on the number of regulations, without distinction between unjust and just laws.
 - 4. The Panelist of Supreme Authority shall not be subject to rebuttal by the panel or question from the floor.

We recommend that these regulations be amended for use in future panels on other subjects:

- 1. In lieu of the requirement that the Panelist of Supreme Authority be a gynecologist (for a panel on abortion), he should be an active practitioner of the discipline under discussion, as an IRS agent (for a panel on prohibiting income tax) or a burglar (for one on protection of private property by the state).
- 2. A seventh member of the panel should be designated to write appropriate letters of apology to any organization or individual invited to present an argument as Panelist, but who relies upon standard rules of debate and is not forewarned of the role of the Panelist of Supreme Authority.

* * *

Adoption of these rules may be expected to rid the party of dissidents, dissenters, and others who are not ready to defer to leaders, candidates for high office, and other persons IN CHARGE. The resulting unanimity and consent can bring party discipline to the level of other political parties.

Bill George went well beyond the call of duty in being of assistance in my campaign. He was by far the largest contributor of time, energy, money ideas and materials.



NJLP GENERAL MEETING

A general meeting was held on February 17, 1979, at the Beacon Manor, Point Pleasant Beach, as part of the NJLP Annual Convention.

Chairperson len Flynn called the meeting to order at 9:30 a.m. Len introduced Ron Wishart, who spoke on "The Libertarian Success Story".

Following Ron's address, nominations for party officers were held. The following members were nominated and unanimously chosen: Len Flynn - Chairperson, Lee Schubert - Vice Chair, Jeanne Macron - Treasurer, Ken Kaplan - Exec. Secretary, and Bonnie Swirsky - Recording Secretary.

Nominations for State Committee Members At Large included: Bill George, Jane Rehmke, Frank Primich, Dale Sutthoff, Jack Moyers, and Mitch Feldman. A vote by membership resulted in the election of Bill George, Jane Rehmke, and Dale Sutthoff.

Len read the names of those chosen as delegates to the national convention. The 15 delegates are: Jack Moyers, Mike Perry, Henry Koch, Chuck Pike, Mitch Feldman, Dan Feldman, Len Flynn, Jeanne Macron, Bill George, Jane Rehmke, Lee Shubert, Bob Shapiro, Barry Siegel, Jose Stella, and Chris. White.

A motion was passed which reads that all NJLP members who belong to National, residing in New Jersey at the time of the convention, will be alternatives.

The meeting was adjourned at 10:30 a.m. and resumed at 2:00 p.m.

After brief discussion regarding the Initiative and Referendum proposalas prepared by Barry Siegel, a motion was passed to have:

- 1. The NJLP call for the state to add Initiative and Referendum to the State Constitution, and
- The NJLP form a committee (under Barry Siegel) to put together such a proposal and to submit it to state legislators.

The last order of business was the nomination of canditates to run for General Assembly in November's elections. Those nominated were:

9th L.D. - Ginny Flynn 10th L.D. - Lucille Bender 12th L.D. - Jack Moyers 26th L.D. - Dick Roth 39th L.D. - Henry Koch

Although his district was unknown at that time, Peter Golomb, from Essex County will be a canditate. Also it was mentioned by Ron Wishart that a canditate will be named to run in the 11th District.

After petitions were circulated, Chris White was named as coordinator of petitions.

All business concluded, the meeting was adjourned at 3:30 p.m.

Statement of Principles

We, the members of the Libertarian Party, challenge the cult of the omnipotent state and defend the rights of the individual.

We hold that all individuals have the right to exercise sole dominion over their own lives, and have the right to live in whatever manner they choose, so long as they do not forcibly interfere with the equal right of others to live in whatever manner they choose.

Governments throughout history have regularly operated on the opposite principle, that the State has the right to dispose of the lives of individuals and the fruits of their labor. Even within the United States, all political parties other than our own grant to government the right to regulate the lives of individuals and seize the fruits of their labor without their consent.

We, on the contrary, deny the right of any government to do these things, and hold that where governments exist, they must not violate the rights of any individual: namely, (1) the right to life—accordingly we support prohibition of the initiation of physical force against others; (2) the right to liberty of speech and action—accordingly we oppose all attempts by government to abridge the freedom of speech and press, as well as government censorship in any form; and (3) the right to property—accordingly we oppose all government interference with private property, such as confiscation, nationalization, and eminent domain, and support the prohibition of robbery, trespass, fraud, and misrepresentation.

Since governments, when instituted, must not violate individual rights, we oppose all interference by government in the areas of voluntary and contractual relations among individuals. People should not be forced to sacrifice their lives and property for the benefit of others. They should be left free by government to deal with one another as free traders; and the resultant economic system, the only one compatible with the protection of individual rights, is the free market.
