NJLP APPOINTS POLITICAL DIRECTOR

At the May 17 State Board Meeting, the State Board appointed NJLP member Mike Buoncristiano of Hoboken as the first Political Director of the NJLP.

Buoncristiano is a veteran of several campaigns for public office, and has won appointment and served on the Hoboken rent control board. He writes a column which is published in both the NJL and grassroots political journal The Patriot, and he co-hosts a cable television talk show called "Mile Square Money Matters - the show that helps you keep an eve on your tax dollar," broadcast by North Mike Buoncristiano



Hudson Cablevision. He is also the owner of Avanti!, a direct marketing firm, also based in Hoboken, which is under contract with the NJLP to provide direct mail marketing services. The new office, whose budget has not yet been established, will initially serve as

the ombudsman of NJLP candidates for public office. Buoncristiano plans to focus on recruiting candidates, helping them to build the necessary organizations, and advising them in financial and fundraising issues. As a way of stretching limited advertising budgets, Mike hopes to pool resources for a "Vote Libertarian" campaign to simultaneously support all Congressional candidates, getting more "bang for the buck" than thirteen separate ad campaigns. 🏋

PRESSER FORUM TOUTED ON RADIO NEWS SHOW

On June 5th, NJLP Chair Dr. Janice Presser was covered at length on the all the news segments of NJ 101.5, one of the leading public affairs radio talkshow stations in New Jersey. Presser had sent the letter below to all of New Jersey's county prosecutors, and her suggestion apparently struck the station management as newsworthy.

The letter:

Dear County Prosecutor:

It has come to my attention, as reported in the press, that New Jersey has standards for prosecution of children that do not apply to adults. It is my understanding that a child who creates a list of persons whom he or she may wish to see gone from his or her life is without the protections of the Constitution and Bill of Rights. Further, it is mv understanding that Democrat and Republican Prosecutors, such as yourself, find these actions to also be grounds for seeking involuntary mental health evaluations of these children. I ask that every prosecutor in New Jersey make a public statement explaining the legal and moral basis for such prosecutions. My interest in knowing the legal basis for such "prior restraint" civil rights prosecutions should be obvious considering my responsibilities as the State Chair of the New Jersey Libertarian Party. However, as a mother, a Jew, and a mental health professional, I am also concerned that a precedent is being created regarding the treatment of children which is overly intrusive into the lives and families of New Jersey.

I ask that we create a forum made up of representatives of your county's office, Judges, and child, civil rights and mental health advocates to openly discuss this subject in the presence of the public and press.

PRESSER ADDRESSES ELECTION LAW ENFORCEMENT COMMISSION

Janice Presser addressed New Jersey's Election Law Enforcement Commission (ELEC), on April 22. ELEC enforces the rules made for elections by the legislature and courts; for example, it was ELEC which ruled on whether the Sabrin Campaign of '97 would be legally considered an "official" campaign.

Presser's comments:

I am the Chair of the New Jersey Libertarian Party. I have an earned doctorate in family therapy and development. I have been accepted as an expert in family and ethics matters in numerous courts. I am the author of five books on the family. I have been a family therapist, college professor, consultant, employee, and president of a manufacturing company. Today, I am here because of the most important job I ever had. I am a mother.

As mothers and fathers all over America do, I raised my children to be good citizens, to share their toys, to clean up after themselves, to treat people in the same way that they wanted to be treated. Those of you who are parents know that is a difficult job indeed, and that it requires both keeping eternal vigilance and always setting a good example. Children learn their lessons from our behavior, not our words. If we talk about equality, but shun some of our neighbors because we believe that they are less than equal, our children will grow up to be bigots. It is when we embrace the spirit as well as the letter of the rules of morality that we teach from our hearts.

As a person whose ancestors were annihilated because they were not "politically correct," I had long held fears that my children would be the targets of prejudice. Believing that "what goes round comes round," I was therefore very careful to facilitate experiences for them where they would meet diverse people with diverse appearance, culture, and beliefs. When it came to politics, that part was easy. My husband and I are long time Libertarians, and we included the children in discussions about history, current events, and philosophy.

I want to share with you some of the points we wanted them to understand:

First, no one should have more rights than anyone else.

Second, coercion or the use of physical force to get what you want is unacceptable.

Third, anyone can grow up to be President, or even a Commissioner.

Our children believed us, but they are no longer children. As children do, they have emerged as fully grown adults, with mature cognitive skills. Now they analyze situations without our help. And it is now that I have a credibility problem. My credibility problem springs from the fact that I taught them the ideals of democracy, just as I learned when I studied the lives and philosophy of the founding fathers and mothers of this country. When they were small, I still assumed that anyone involved in government would believe in the Constitution and the Bill of Rights. I now wonder if I was right. ELEC's actions have told our children that Republicans and Democrats have more rights than Libertarians, and other smaller political parties. ELEC's actions in securing and spending taxpayer dollars for gubenatorial matching funds are coercive.


And the composition of the members of ELEC—half from the Democrat Party and half from the Republican Party—mean that some people cannot ever hope to be a Commissioner, much less President.

I came here today to ask you in the name of parents all over New Jersey to set a good example and keep the values that inspired the founders of this nation.

They wanted us to have the ability to speak freely and be heard. We cannot do this if our candidates cannot be in the debates. They wanted us to be free of coercion, to make the everyday choices that define a life lived in freedom. We cannot do this if we are stifled by the majority parties' stranglehold on the system. And they wanted us to believe that there could be liberty and justice for all. We cannot say this ideal is reality as long as there are rules for some that are not rules for all.

And so I ask you as a parent, citizen, and Libertarian, that you act in the spirit of our founders. Stop letting Republicans and Democrats monopolize the podium. Open the election process to the greatest number of participants. Realize that when you don't allow some people to become part of the system, we all lose.

And, please, help me restore my credibility with my children. \blacksquare



ASK THE CAMPAIGN PRO

It seems to me that we as a party are in need of a serious image makeover. Is there anyplace we can look to for an example?

Yes. The recent experience of the Labor Party in the United Kingdom proves useful. Not primarily in the policy sense but, as you mention, largely in image. Not many years ago the Labour Party was a polyester-clad group of Stalinist retreads, solidly trounced by the Tories in three general elections and almost consigned to the ash heap of British history. Their leaders were strident, inarticulate political amateurs obsessed with unwinnable fights, and were more concerned with ideological purity than with holding elective office to see their agenda become a reality (beginning to sound familiar?) But then a group of young aggressive modernizers managed to get control of the levers of the party through internal skullduggery and proceeded to drag Labour kicking and screaming into the media-driven, image-conscious 1990s. They started to address issues that mattered to voters on a day-to-day basis. They cut their hair and wore attire befitting their high profile. They changed the party name to New Labour (thus making a seemingly clean break with their clunky past); they put the ideologues in the policy units and the professionals in the political units; they changed the party logo and did a host of other things that made the public comfortable with them in government. They call it "rebranding."

Today, with a massive majority in the House of Commons, they are "rebranding" Britain.

What's the line between clever and slick?

Excellent question. Answer: a damned thin one. My rule, because I don't do a lot of work in the area I grew up in and thus my perspective is generally that of an outsider, is that if I personally like the spot too much, I'm suspicious of it. As a South Floridian by upbringing (and of Colombian ancestry by the grace of God), I tend to like the on-the-edge stuff. But I know full well that few in Kansas, Minnesota, or most other places in this fruited plain share my attitudes. And if you do something too slick, too smartass, just too simply amusing in a place that isn't going to get it, and you're going to pay for it at the polls. Your best bet? Put together a focus group of locals and make sure they buy on to the message. When in Rome...

What's the toughest race you've ever been involved in?

Hard to say; I've been in more than one stiletto fight in a dark alley. Maybe the toughest was also the one with the slimmest margin; knocked off a Republican incumbent in a 1995 County Commissioner election in Pennsylvania by 132 votes out of 60,000 cast. Of course, I guess by definition the toughest ones are the ones you lose. Toughest one of those was the State House primary race in 1996. Like an idiot, I was sure I was going to win and told everyone I knew the same. Naturally, I got my clock cleaned. That was the last time I publicly predicted an election result that I was involved in.

Realistically, how long must we wait before our party catches on?

How long did it take in 1992 for Ross Perot to catch on? Not a lot of time, that's how long. In this instant media age, they who get their message out -targeted and widely distributed- can gain instant credibility. Also, Perot had working for him at E.D.S. in Dallas, numerous ex-military types who knew how to run an organization.

We play our cards right and "rebrand"? -could be So for us? tomorrow night!

We go on with business as usual? NEVER!

Since, by your own admission, you've never run a race with a Libertarian client, do you really deserve to be called a "Libertarian" political consultant?

No. But then I have a trick right knee, and I don't deserve that either.

Not only was there an elaborate simulation of an actual election (in this case, a Libertarian Party Congressional Primary in Indiana), but there was a simultaneous simulation of pre-World-War II Europe and its environs.

Two of the candidates were from Delaware, and the third yours truly, fighting hard and dirty, and winning with four times the resources of one opponent and completely knocking the other out of the race. It's preparation-for this year's congressional race. 🌋

EDITORIAL: THE LIBERTARIAN PARTY ELECTION PROCESS

The 1996 LP National Convention was an exciting, reassuring, inspiring, and productive event. But it wasn't perfect, and an important improvement needs to be made for this year's convention.

Among other business, the Party spent much of two days examining refinements to its Platform, adopting some and rejecting others; spent much of two days exploring a plethora of candidates for its presidential nomination; and an hour to examine and choose a Chair. If that doesn't sound incongruous, it should: the Chair of any party out of power is more important to his or her party than *any* politico of the status quo parties. And we chose ours without hearing either candidate address the convention. Only nominating speeches for the rival candidates were presented, and of course the candidates themselves didn't present them.

One New Jersey delegate voted for None of the Above, not because he didn't have a preference, but to protest the fact that the delegates (many of whom knew little or nothing about either candidate) had no chance to hear them out and compare them. It's not reasonable to expect informed decisions under those circumstances. And there will be more time available this year, because no presidential nomination must be made.

Let's make sure that all National Committee seats are filled only after the entire convention has heard all contenders for each seat.

HOW I LEARNED TO STOP WORRYING ABOUT GUNS

Okay, I'll admit it. I was an effete intellectual snob. I really couldn't help it. Born and reared in New York City, college student in the 60's, liberal family. I hated the NRA. They were killing Bambi and Thumper and hanging their heads over the fireplace.

Besides, my family was Jewish and didn't eat venison. I did not relate to gun owners, who I lumped with rednecks, moonshiners, and hillbillies.

I blithely accepted the downsides of big city living: the violent crimes, the crimes against property, and the petty, everyday annoyances. The idea of self-defense was not widespread in this pre-Bernhard Goetz era.

But I grew increasingly aware of the parallels between the history of Jews in Europe and African Americans in the United States. The glaring burden they bore, whether in a small Alabama town, large northern city, Eastern European shetyl (small ghetto), or the huge Warsaw Ghetto, was that they were not permitted to have guns. It was not that they were prevented from hunting. They were prevented from defending themselves against those who would hunt them.

Even then, old ideas die hard. More so, if you need to believe that they are correct. Like most people who have been victimized, I realized that my strategy was to placate oppressors, not challenge them. That realization was the beginning. I began to think in terms of my life versus a predator's. Where before, wounding or killing another human being was unthinkable, now it became a possibility if it meant survival of my family or myself. In some situations, survival requires self defense with a weapon.

Having gotten this far, I am now ready to learn to shoot. I still won't be shooting Bambi and Thumper. I don't want to eat them, and I don't want to hang their heads on the wall. I only want to remind myself of what I have learned: that you are not truly free until you have claimed your natural right to defend yourself.

THE VIEW FROM HOBOKEN

A PROVEN WAY TO RESTRAIN TAX INCREASES - Supermajority for Tax Hikes Makes Sense for New Jersey. According to the Cato Institute, taxes rose five times faster in states without supermajority requirements, a sound argument to press for this important change without delay.

"Supermajority requirements merely ask legislators to reach a broader consensus when they want to take more money out of their constituents' pockets," Cato analyst Dean Stansel told a New Jersey State Senate committee recently. The legislature is considering a bill that would require that all tax hikes be approved by a three-fifths supermajority of both houses.

Stansel noted that there are now 13 states with supermajority provisions—six of them have been in force since 1990. "Residents in states that already have supermajority requirements found that their tax burdens increased by only 1.1 percent from 1980 to 1996, while residents in states without such requirements saw state taxes as a share of personal income go up by 5.4 percent," Stansel told the senators.

"Supermajority requirements also have proven to have a noticeable impact on top tax rates," Stansel reported. "In 10 states —all without such requirements—residents face higher top personal income tax rates today than they did in 1990. None of the 13 supermajority requirement states have higher top rates than they did in 1990, and 3 have reduced their top rates."

Stansel concluded, "Today, Americans have to spend more on taxes than they do on food, clothing, shelter and transportation combined. Is it too much to ask that more than a simple majority be required to make that burden even higher?"

OPPORTUNITY DEFENDED – It's only fair to give credit when due: kudos to Assemblyman Joseph Azzolino for his stand on the basic freedom to run a home-based business. He recently pointed out that New Jersey has between 250,000 and 500,000 people working out of their homes. It makes sense to encourage opportunity like this since most businesses in America were started in someone's home. Azzolino is right as quoted in New Jersey Business news: "Home-based business is entrepreneurship at its best."

What doesn't make sense is that the Senate is apparently kowtowing to the League of Municipalities to block a basic freedom that has certainly contributed heavily in the past to America's world leadership in commerce and New Jersey's stature as a major home for business and technology. Anybody remember how ADP got started? C'mon, Senators, be statesmen, not just purveyors of patronage. We need freedom to prosper much more than we need a slew of anti-opportunity inspectors inflating city budgets.

HOW TO BOOST THE VALUE OF OUR STOCK – How to get rich: get a Congressional staff job at \$100,000. If you think Congressmen are paid too much, wait until you hear how much Capitol Hill staffers get: 554 Congressional employees make over \$100,000 a year—a number that's grown by 41% since 1995 according to a study in Roll Call newspaper. This is an all time high for Washington's exclusive "\$100,000 Club."

The total taxpayer tab for just these 554 big money bureaucrats? Over \$63 million a year. Despite the so-called Republican Revolution of 1994 and Newt's Contract With America, 81 GOP Congressmen and Senators pay out \$100,000-plus salaries to staff members, compared to 59 Democrats.

Does it make sense that we, the taxpayers, the employers of leagues of federal minions, give our employees a better deal than the boss gets? Since 1980, compensation for federal workers has risen five times faster than earnings for private sector employees, according to a study by economist Wendell Cox.

That's a growth factor of 25% for the federal bureaucrats versus a mere 5% for their employers, you and me. It's time for a massive lay-off that will certainly boost the value of our stock.
