NJLP STATE COMMITTEE MEETING

The NJLP State Committee met on August 13 at Patti's Restaurant in New Brunswick. Present were Duprey, Hoegberg, Flynn, and Peters. Absent were Friedlander, Brazil, Swirsky, Zeldin, Meinshausen, Kerr, Fallon, and Polombo.

Rich Duprey opened the meeting at 7:45 PM with a report on the effort to permit voter registration as Libertarians. The next step will be to meet with the leadership of the legislature.

Two motions were unanimously approved by the committee. First, the Essex County LP organization with Nick Polombo as Chair was approved. Second, October 1 was set as the final application date for the NJLP volunteer for 1987 state convention chair. The final selection of convention chair will be made at the next LP meeting after 10/1.

Rich then discussed the status of the Garden State Libertarian newspaper. The NJLP can afford to switch to a bimonthly paper for an estimated \$100 per issue, if the printing cost is \$500 and we have \$400 in advertising. Volunteer printers and people to get advertising are needed.

Mike Pierone was appointed Advertising Manager for the GSL. Members willing to help gain advertisers or advertise themselves should call Mike at 201/827-5226. Mike was also appointed County Organizer for Sussex County by Chairman Duprey.

# Commentary on Liberty

Two different approaches to funding rail lines have been in the news lately. New Jersey officials are going to use some \$90 million of your tax dollars to rehabilitate the rail line to Atlantic City so that Amtrak can whisk gamblers to highly-profitable and eleven privately owned casinos there. In Washington, D.C., however, a group of private investors is considering building a trolley line linking Dulles Airport with Washington's subway system. The 16-mile line would cost about \$300 million and would be one of the first privately financed transit lines in half a century. The Dept. of Transportation is encouraging this venture. The Dulles line investors hope to tie the transit system into real estate ventures that will more than pay for the line itself. With the real estate and casino tie-ins possible in Atlantic City and environs, there is absolutely no reason (except taxpayer apathy) for spending taxpayer funds for that project.

'A big Philly boo to Sen. John' Stauffer, majority leader of the Pennsylvania Senate. Stauffer is a prime backer of the bill that requires all state and local public works to use steel made in the USA. Stauffer also helped to extend the law so that it covered motor vehicles too. However, the hypocritical Sen. Stauffer himself drives a 1985 Audi which sells for \$25,000. With a helping subsidy from the taxpayers who have to pay more for public projects, the Audi only costs him \$25 per month. The royally unrepentant Stauffer smirks, "I'm driving a fine automobile, which happens to be made in Germany. It's a free market and I'm a free citizen like everyone else." But by the time Stauffer gets done with us, the politicians will be the only free citizens left.

### SELECTIVE SERVICE RESISTANCE UPDATE

Here are some interesting figures about draft registration. The SS and the General Accounting Office estimate there have been some 7.5 million violations of Selective Service regulations, broken down thus: non-registration, 500,000; incomplete registration forms, 1,000,000; failure to notify change of address, 6,000,000.

Meanwhile, there have been twenty indictments for failure to register, nineteen of those involving people who publicized their nonregistration or reported it to the government in defiance. Five indictments were withdrawn by the prosecution, three of them when the victim agreed to register.

Of these, fourteen have been convicted, including four who pleaded guilty. One of them is pending appeal. Eight served time in prison; the most was the six months spent by Ben Sasway, who is out on parole. Only one is currently in prison--Dan Rutt, serving four months in a "halfway house."

The worst fine was the maximum \$10,000 imposed on Rusty Martin, who was also sentenced to three years' probation and forced to register, attend two citizenship naturalization rituals.

### A RICE TO THE SUBSIDY TROUGH

Do government subsidies distort the economy? Butte County, in northern California, offers us some suggestive evidence in the case of rice farming. It seems that last year there were 75 new rice farm operations in the county; this year there are expected to be another 60. A robust local farm economy? Guess again.

What caught the eyes of some local journalists was the fact that during this expansion little or new land was being put into production — understandably, since rice prices have plummeted, and well—established farmers are having a hard gb of it. So what's happening? In the words of a local administrator of government rice subsidies, these new "farmers" are "farming the program."

One local farmer, who had applied for and received the maximum \$50,000 subsidy in 1983 decided that he would subdivide his farm and lease it to 11 other people in 1984, including members of his family, his employees, and his attorney, each of whom was now entitled to receive \$50,000. And for 1985 the number of operating units on his farm has jumped to 20, each claiming to be an individually financed, formed and operated farm, and each eligible for \$50,000 in subsidies, amounting to a cool one million dollars. Maybe in a free market rice farmers would spend more time sowing rice than reaping subsidies.

# Give schools back to the public

To the Editor:

In answer to Tony Auth's cartoon and Ellen Goodman's column of July 18, I don't believe anyone is suggesting that our public schools become "a roof covering a thousand religious tutors," as Ms. Goodman says. The original Tower of Babel would indeed be Mozartian in harmony by comparison.

What most people are saying, however, is that in the land of the free and the arsenal of excellence, the education of our children is being concentrated more and more in the monolithic public school system whose achievement has been described by a national commission of educators as a condition that, were it created by a foreign power, we would consider an act of war.

Indeed, in many respects our public schools contradict some of our most cherished ideals.

America stands for freedom; our public schools stand for compulsion through economic pressure. Parents who cannot afford to bear the double burden of paying school taxes for public schools and tuitions for a school of their choice are forced to send

their children to public schools.

America stands for competitiveness that begets excellence and efficiency; public schools stand for a monopoly of ideas, and economic inefficiency and waste go inevitably with monolithic systems.

The public school lobby, especially the National Education Association, has been brainwashing us that the public school is the American school, the melting pot school, the value-neutral school that does not offend any point of view, hence the only school to be supported by everybody's tax dollars.

However, America is not a molten, faceless mass. The melting pot analogy reflects only a small aspect of our composite. America, rather, is a mosaic in which each, component retains its own brilliance while cemented to the others by love of freedom.

The time has come to reconsider our ideas in education and to discard mediocrity. It's time the education tax dollar followed the consumer in the form of education vouchers, rather than the institutions that sell education. If all parents had the ability to pay

for the education of their children at a school of their choice, we would soon see schools shape up to attract the vouchers. The schools that provide the best education will flourish, the mediocre schools will eventually close down. That's the American way.

With this single change we would not only get off the Tower of Babel but also improve academic quality and, with the efficiency that goes with competition, reduce the taxpayers burden. This change would also permit freedom of choice in values and philosophy, thus eliminating problems with school prayer and impermissible entanglement of church and state.

Also, the entire problem of discrimination, particularly racial discrimination, will melt away when all parents have both the right and the financial capability to choose the school they deem best for their children.

Let's give it a try. The only risk we run is the loss of mediocrity and of insensitivity to our values.
