Pawlowski Campaign Update

As the NJL goes to press we are within a week of qualifying for matching funds and entry into the debates. The last time I wrote to you, I was urging you to donate to fund a mailing. All donations made helped, and special thanks go out to those that donated over a \$1,000 to make this possible. The 41,000 piece mailing should already be in the hands of the recipients, and we can only wait to see the response.

We now have credit card processing available on the website. Remember that you must still print a donation form, complete the info required, sign it, and return it to the PO Box or the toll-free fax number for your donation to count.

I looked into professional fundraisers. I found one that would telemarket for \$28 / operator / hour, with no guarantee on performance. Another wanted 90% of the funds raised, then balked at the prospect of having to deal with compliance (signature on donation form).

I want to extend an opportunity to Libertarians to earn money to raise donations for Pawlowski For Governor. For donations processed before August 31, the campaign will pay 90% of the qualified donation to the person that raised the funds. I will announce on Sept 2 if the program will continue.

You must pre-register as a paid fundraiser, and you cannot be paid a commission on your own donation. This will be considered earned income and the commission recipient will receive a 1099. This means that you will be liable for any taxes owed on your earnings. You might also consider taking the commission, then donating that back to the campaign. The earnings will be yours to spend in any way you choose.

Libertarian Candidate Helen Medwin Dies

Former NJLP Congressional and State Senate candidate Helen Medwin died August 24 at age 49. She had been returning home from work in Cherry Hill where she was employed by Innovative Software Solutions when she pulled to the side of the road and dialed 911 and was shortly thereafter pronounced dead of a heart attack. Helen had had a history of high blood pressure, but no known heart problems

Helen is survived by her husband Al, her daughter Jeanette, and brothers Steve and Tom Leete. She was a Phi Beta Kappa at Rutgers where she graduated in accounting, a Second Degree Black Belt in Tae Kwon Do, and was a frequent panelist on Shad Woolley's libertarian TV show, A Third Point of View.

A memorial service was held at the Unitarian Universalist Church in Lincroft where she was a member. Her brother Steve, a rocket scientist with NASA, sang one of Helen's favorite songs, Imagine by John Lennon.

Helen will be missed by her friends, family, and associates and her four beloved cats.



Minutes of the State Board Meeting of August 21, 2005

Chair Ken Chazotte called the meeting to order in Tumutly's Pub, New Brunswick, at 1:08 pm.

Present in addition to Chazotte were Jay Edgar, Emerson Ellett, Lou Stefanelli; At-large members Virginia Flynn, Bill Hunsicker, Elizabeth Macron, Robert Hull, Len Flynn; County representatives Kevin Ferrizzi (Gloucester), Peggy Hunsicker (Mercer), Pat Bontempo (Ocean); Frank Warren (Somerset). Absent: Dan Iannetti (Camden) and Dan Hurley (Monmouth). Ray Babecki (Middlesex) has resigned. The Camden County Representative position is now vacant due to two absences.

Gubernatorial campaign report. In order to raise \$300,000 by August 31 the Pawlowski campaign has sent out national mailings to 31,000 people on the Libertarian Party list and to 11,000 people on the Marijuana Policy Project list. The 500 word ballot statement is being prepared. The campaign is considering an additional fund raising appeal on a commission basis. Jeff Pawlowski thanked the donors, especially those who dug deep, whose generosity financed the fund raising mailing. He pledged to run an active campaign whether or not sufficient funds are raised to get him into the televised debates.

Chair report. Chazotte thanked Ken Kaplan and Pat Bontempo for their service as Interim chair and vice chair respectively. The chair would like to increase membership. One way would be to adopt John Paff's idea to use the Faulkner Act to place initiatives on township ballots. Chazotte urged the importance of attending town and school board meetings. The State Board decided it should take no further action regarding the turmoil of earlier this year.

The treasurer's report was received.

The secretary reported that comments received pertaining to the draft minutes of the July 9 General Meeting have been incorporated, and the minutes have been published in the newsletter.

Assembly candidate reports.

Kevin Ferrizzi, 5th District, will speak at an eminent domain gathering of the Castle Coalition.

Bill Hunsicker and Jason Scheurer, 15th District, are considering radio ads on 101.5 FM.

County organizing. Pat Bontempo volunteered to prepare an article for the newsletter (and the web site) about the process for organizing unorganized counties.

New members. National continues to send us cumbersome 6,000 name dumps. Hull will go through the NJLP database and send Ellett a list of new members. Hull can't use the dump. Dan Karlan, LP national committee member, said he will ask National how state parties can receive useful and timely new member data and also how they can get the names of prospects who contact the national party, for follow up and recruitment.

Financial audit. The audit team will select a date for the audit.

Project Full Slate. Len Flynn is heading up the effort to recruit and support candidates in all 13 Congressional districts in 2006. He will prepare a fund raising letter for mailing following the election this November.

Reimbursement of LNC expenses. Jay Edgar MOVED, (Virginia Flynn seconded) that the NJLP grant \$100 to our LNC representative toward expenses incurred in attending LNC meetings. The motion CARRIED.

Camden County representative. Kevin Ferrizzi, Gloucester/Camden chair, will canvass Camden County for a representative to the State Board.

Federal Election Committee meeting. The chair will ask the LP to send a representative.

Eminent domain. Frank Warren reported that the LP of Central New Jersey is considering Faulkner Act remedies against eminent domain.

Bylaws. Copies of the bylaws dated July 9, 2005 were distributed. Copies are available for \$1 from secretary@njlp.org

Announcements.

The LP of Central New Jersey will meet August 26 at the Lone Star Steakhouse on US 22 in Scotch Plains at 7:30.

Project Full Slate

The purpose of Project Full Slate will be to gain 13
candidates on the ballot for the New Jersey Libertarian
Party for the 2006 campaign for Congress. A full slate
means every voter in the state will have a Libertarian
alternative running for Congress in 2006. Enhanced party
recognition and more prominent ballot position are
additional benefits of a full slate.

In this effort we anticipate using paid petitioners as
needed for difficult Congressional districts, that is districts
where the NJLP has rarely or never had a candidate. If
necessary, we shall recruit NJLP members in difficult
districts to be "trademark" candidates without further
campaign obligations. These "name only" candidates will
have other people do their petitioning plus handle
campaign responsibilities.

Question to NJLP members: Would you contribute
to the NJLP Federal Fund to assist in this project?

How will the money be spent?

Money will first be used for petitioning as needed,
then the funds will be used for campaign support and
generic "vote Libertarian" advertising which supports all
candidates. Finally, remaining funds, if any, would be used
on a case-by-case basis for promising candidates ("impact"
and "challenge"). The concept for use of the Federal Fund
money collected through Project Full Slate would be that it
is used first to benefit all candidates.

A draft plan for Project Full Slate will be prepared
for consideration by the membership at the November
2005 General Meeting after the 2005 campaigns are
completed. For a benchmark for fundraising there would be
150 signatures needed per candidate and 13 Congressional
districts or 1,950 signatures needed on nominating
petitions. At one dollar per signature less than \$2,000
could be budgeted for the project.

The core issue no one wants to face

Kal Wagenheim ("Why don't Americans trust Bush on SSI?") in the June 26 issue of Suburban Trends evidently accepts the premise that people are too stupid to plan their own retirement and therefore the government should do it for them.

Wagenheim seems to make light of those legislators who 70 years ago warned that Social Security was a hoax and would lead to more centralized power

for the federal government. Those legislators who spoke up and resisted Roosevelt's plans to regiment and collectivize our country have been proven correct over time.

Just because other nations have embraced semi-socialist or outright socialist ideas doesn't mean we should. People immigrated to America from the Old World to get away from government controls over their lives and property. Government at any level can't give anybody anything that it first doesn't take from you or someone else. Politicians (like Wagenheim's hero Roosevelt) and other government bureaucrats are the last people to trust handling your economic future.

As for the current occupant of the White House, his plans for Social Security "reform" are too little and don't go far enough. If Bush and his fellow "compassionate conservatives" were truly defenders of individual liberty and free choice, they would at the very least have proposed that participation in the Social Security system be totally voluntary.

You see, that's the core issue that no one wants to face – namely

that Social Security like other welfare state schemes is based on compulsory participation and state imposed force.

This kind of thinking is totally at odds with America's Libertarian tradition of individualism and free choice. Sadly, most people don't give a damn about their freedom being eroded by subtle means such as Social security.

Brandeis was a person who took positions that I would sometimes have disagreed with, he was correct when he said, "Men born to freedom are naturally alert to repel invasion of their liberty by evil-minded rulers. This site reminded me of the old lawyer joke... "What do you call 1,000 lawyers at the bottom of the ocean? A good start!"

PACLEANSWEEP.COM isn't a libertarian organization or site, but it's a great start. Throughout the country, the "clean sweep" strategy - ousting all incumbents from office - has gathered more grass-roots interest than many other attempts at reforming government.

PACLEANSWEEP.COM is devoted to kicking every incumbent out of the State's General Assembly. Their outrageous pay raise shenanigans were the final straw for Founder Russ Diamond, whose site is one of the best we've seen. His FAQ list alone is worth a read, and I was particularly pleased by this question and answer:

Q: Should I be worried about replacing experienced legislators with novices and/or political neophytes?

A: No. The legislature doesn't run the state. Various agencies, departments and commissions perform the day-to-day duties of the Commonwealth. Even if the new legislators do absolutely nothing all year besides approve a budget on time, Pennsylvanians would be better off than they

are with the current crop of lawmakers, who have allowed the General Assembly to become a corrupt institution. Political neophytes would be much preferable to career politicians.

For a non-partisan web site, PACLEANSWEEP.COM often rings with libertarian truths. In his "Founders Statement" Diamond writes (of the PA General Assembly): "They have convinced many poor souls that the terms Republican, Democrat, Libertarian, Constitution, Green and others are more important than anything else. They could not be further from the truth. There comes a time in every person's life when they simply need to stop and say enough is enough. For this one individual, that time has come. Many citizens across Pennsylvania apparently share this opinion..." Writing about the rights encroached upon by government, Diamond says "I am aware that the Constitution of the Commonwealth of Pennsylvania does not grant me any rights, but instead merely enumerates some of the inherent rights I own as an individual", which could be right out of a libertarian primer.
