### **\$55 FOR A FLOPPY DISK? WE'LL SEE YOU IN COURT, EDISON**

NEW BRUNSWICK – On June 3, 2004, the Libertarian Party of Central New Jersey (LPCNJ) filed a civil lawsuit against Edison Township Clerk Reina M. Murphy. The suit (which hasn't yet been served upon Murphy) challenges Edison Township's policy of charging public record requestors \$55 for a 3.5 inch computer disk. The suit asserts that \$55 is "unreasonable, discourages access and violates the right of access to public records" under both the Open Public Records Act and the common law. The LPCNJ is being represented by Montclair lawyer is Richard Gutman (phone 973-744-6038).

The suit arises out of LPCNJ Secretary John Paff's May 11, 2004 request for a computer disk containing some of the Township Council's recent meeting minutes. Paff had sent Murphy a blank 3.5 inch disk and a \$2.00 check for return postage. In her May 20, 2004 response, Murphy returned Paff's disk and check and informed him that Edison's fee for making a diskette is \$55. She also informed him that minutes are free of charge on the Township's website. However, the website is about six months behind (see <http://www.edisonnj.org/council/minutes/2004.asp>) and the minutes Paff requested aren't available there yet.

"It's a total gyp." said Paff. "Office Depot sells disks for forty cents apiece. How did Edison come up with \$55?"

### **FREEHOLDERS TAKE HEED OF “SUNSHINE LAW” SUGGESTIONS**

SOMERVILLE – In a May 14, 2004 letter, Somerset Freeholder Director Denise M. Coyle agreed with the Libertarian Party of Central New Jersey (LPCNJ)<sup>1</sup> that the Board needs to review its closed-door meeting procedures. Coyle's letter was in response to the LPCNJ's April 2, 2004 letter which called for some procedural changes.

According to New Jersey's Open Public Meetings Act (OPMA), governing bodies are allowed to discuss certain subjects behind closed doors. These closed meetings are known as executive sessions. However, the OPMA requires a governing body, before going into executive session, to pass a resolution in public "stating the general nature of the subject to be discussed." In its April 2, 2004 letter to Coyle, the LPCNJ pointed out that the executive session resolutions passed by the Freeholders were typically so general and vague that they provided the public with no real sense of the subjects being discussed behind closed doors. The party also requested that the Freeholders develop a better procedure for approving executive session minutes and releasing them to the public and that the minutes themselves be more comprehensible.

Coyle thanked the LPCNJ for its suggestions and vowed to "review our procedures to make sure that the letter and spirit of the OPMA continue to be met."
